Subject: 5 ARRESTED FOR MURDER IN LITTLE HAITI

The Miami Police Department is actively investigating two tragic incidents that occurred on Monday, July 1st, 2024, resulting in the loss of two young lives.

At approximately 12:30 pm, 20-year-old Treyshawn Wright was shot and killed while driving a black Cadillac Escalade in the area of 7 Ave NW 58 St. Just a few hours later, at approximately 6:30 pm, another shooting took place at 2 Ave NW 52 St, resulting in the tragic death of 24-year-old Andre Mitchell.

The Miami Police Department's Homicide Unit has been working tirelessly around the clock to investigate these incidents. We have collaborated closely with the Miami Dade Police Department, the Broward Sheriff's Office, Margate Police Department, Pembroke Pines Police Department, Ft. Lauderdale Police Department, and the Georgia Bureau of Investigations to ensure everyone involved in these heinous acts is apprehended and held accountable.

In a significant development, the Miami Police Department's Homicide Unit orchestrated a coordinated, simultaneous execution of multiple arrest and search warrants throughout the City of Miami, Miami Dade and Broward Counties, and Atlanta, Georgia. The purpose of these arrest and search warrants was to gather additional evidence and information related to the ongoing investigations and arrest the following individuals for 2nd Degree Murder:

- Jamauri James Glover 8/13/2001
- Sheldred Johnson 5/6/2005
- Michael Higgs 1/1/2007
- Symarri Williams 2/21/2005
- Manuel Orlando Rivera 2/6/2003

As a result of these efforts, multiple firearms have been recovered, along with other crucial pieces of evidence. The investigations remains ongoing, and our dedicated team of law enforcement professionals is committed to bringing justice to the victims and their families.

We urge anyone with information related to these incidents to come forward and assist us in our investigation. Your cooperation is essential in ensuring that those responsible for these senseless acts of violence are brought to justice.

The Miami Police Department expresses it deepest condolences to the families and loved ones of Treyshawn Wright and Andre Mitchell during this difficult time. We remain steadfast in our pursuit of justice and will continue to provide updates on this investigations as it progresses.
